
## 51 gallons/conn/day 249k af/yr savings

Each service connection in Texas loses an average of 51 gallons of water every day.

Achieving a 75th percentile performance level could save Texas about 249,000 acre-feet per year.

#### 3. Creation of a statewide water conservation awareness campaign

The Council recommends that, subject to available state revenue for the 2023-2024 biennium, the Texas Legislature appropriate up to \$3 million per year to the TWDD to implement or contract with another entity for the statewide water conservation public awareness program that was created by the Texas Legislature in 2007 with the passage of Senate Bill 3 and House Bill 4.

At local, regional, and statewide levels, water conservation and efficiency continue to be a crucial strategy for meeting our growing water demands. Conservation and efficiency targets can be advanced through various strategies such as water loss reduction, plumbing and fixture codes, etc., but must also be addressed through public awareness and behavioral/cultural changes. While some entities are working to advance water conservation public awareness through localized campaigns, Texas has not yet funded a statewide, coordinated approach to water conservation public awareness.

The need for a statewide water awareness campaign is not new, and the legislative recommendation that it be funded by the Texas Legislature was first recommended by the Council in 2016. A history of actions towards establishing a statewide water campaign is included below:

- 2004: Water Conservation Implementation Task Force discusses the need for a
  coordinated, statewide water conservation public awareness campaign. Texas Water
  Foundation initiates and funds statewide polling to identify how different population
  segments value water. This data leads to the creation of the TWDB's Water IQ in 2007, a
  public awareness program aimed to increase knowledge of drinking water.
- 2007: Texas Ligislature formalized the need for a public awareness campaign by adding it to Texas Water Code, which reads "The executive administrator shall develop and

# Texas Water Fund Legislation (88<sup>th</sup> session)

- Senate Bill 28
  - Created the Texas Water Fund, New Water Supply Fund for Texas, and the Statewide Water Public Awareness Account
- Senate Bill 30
  - Authorized a onetime, \$1 billion supplemental appropriation of general revenue to the Texas Water Fund, contingent on enactment of SB 28 and approval of SJR 75 by voters
- Senate Joint Resolution 75
  - Proposed constitutional amendment creating the Texas Water Fund to assist in financing water projects in Texas
  - Directed TWDB to allocate no less than 25 percent to the New Water Supply Fund for Texas

## **Texas Water Fund**

- Allows the TWDB to transfer money to certain existing TWDB financial assistance programs
- TWDB must ensure that a portion of the money is used for:
  - water infrastructure projects for rural political subdivisions and municipalities with a population of less than 150,000
  - projects for which all required state or federal permitting has been substantially completed
  - water conservation strategies
  - water loss mitigation projects
  - the statewide water public awareness program

#### Frequently Asked Questions

#### 1. Q: What is the Texas Water Development Board (TWDB)?

A: The mission of the Texas Water Development Board is to lead the state's efforts in ensuring a secure water future for Texas. Our mission is a vital part of Texas' overall vision and the state's mission and goals that relate to maintaining the viability of the state's natural resources, health, and economic development.

The TWDB's main responsibilities are threefold: collecting and disseminating water-related data; assisting with regional water supply and flood planning that contributes to preparing the state water plan and state flood plan; and administering cost-effective financial programs for constructing water supply, wastewater treatment, flood control, and agricultural water conservation projects.

Since 1957, the TWDB has been charged with addressing the state's water needs. The TWDB works to ensure Texans have access to sufficient, clean, and affordable water supplies that foster a healthy economy and environment.

#### 2. Q: What is the Texas Water Fund?

A: In 2023, the 88th Texas Legislature passed Senate Bill (SB) 28 and Senate Joint Resolution (SJR) 75 providing for the creation of the Texas Water Fund. In addition, SB 30 authorized a one-time, \$1 billion supplemental appropriation of general revenue to the Texas Water Fund, contingent on enactment of SB 28 and approval of SJR 75 by voters. Proposition 6 (the proposition for SJR 75), creating the Texas Water Fund to assist in financing water projects in Texas, passed on November 7, 2023, with more than 77 percent in favor.

The Texas Water Fund will be a special fund created in the state treasury outside the general revenue fund to be administered by the TWDB. SB 28 directs that the TWDB may only use the Texas Water Fund to transfer money to the following funds or accounts administered by the TWDR:

- The New Water Supply for Texas Fund, a new fund created by SB 28.
- The State Water Implementation Fund for Texas (SWIFT) and the State Water Implementation Revenue Fund for Texas, which support the <u>SWIFT financial assistance</u> <u>program</u> that provides low-cost financing for projects in the state water plan.

#### Texas Water Fund Issues for Consideration and Request for Feedback

Response requested by April 30, 2024

The Texas Water Development Board (TWDB) is seeking public input to assist in implementing the <u>Texas Water Fund</u>, a special fund in the state treasury outside the general revenue fund to be administered by the TWDB.

Administrative rules are not required to implement the Texas Water Fund itself; however, stakeholder feedback is requested to inform funding priorities as well as the administration of the programs to which funds may be transferred. Formal rulemaking for the water loss technical assistance program required by Senate Bill 28 has already taken place.

Other rulemaking related to the Texas Water Fund may include:

- Minor changes to the Rural Water Assistance Fund rules in 31 Texas Administrative Code Chapter 365
- Minor changes to financial assistance rules in 31 Texas Administrative Code Chapter 363
- New rules for the New Water Supply for Texas Fund, as a new subchapter in 31 Texas Administrative Code Chapter 363

The TWDB is seeking stakeholder input via three survey instruments:

- Texas Water Fund Survey 1: Financial Assistance for Water Infrastructure Projects
- Texas Water Fund Survey 2: New Water Supply Fund for Texas
- Texas Water Fund Survey 3: Statewide Water Public Awareness Program

The information requested in these surveys is intended to solicit general and specific feedback that will inform formal rulemaking and other implementation efforts. Written feedback may also be submitted to <a href="mailto:TexasWaterFund@twdb.texas.gov">TexasWaterFund@twdb.texas.gov</a>. Information provided in the surveys or submitted via email is requested by April 30, 2024.

In addition to the surveys, we will be inviting public comment on the Texas Water Fund at TWDB Board meetings through March and providing information at upcoming financial assistance workshops around the state. We will also be hosting a stakeholder meeting in Austin in March and a stakeholder Board meeting in Lubbock in April. The Texas Water Fund is not a new financial assistance program itself; rather, it allows the TWDB to provide funding through certain existing financial assistance programs and the newly created New Water Supply Fund for Texas. The TWDB is working to implement the Texas Water Fund and is seeking stakeholder feedback to inform funding priorities as well as the administration of the programs to which funds may be transferred.





We built the Hub with benefits to the users in mind following the principles of FAIR (Findable, Accessible, Interoperable, and Reusable) data.




